The medium gable roofline is above exposed rafters and support brackets on this craftsman bungalow. It is sided with narrow clapboard and has a recessed porch supported by a single square column. The signature of the builder is at the top of the gable, a crossboard connected to the endboards and a rectangular window with decorative latticework instead of glass.

This house contributes to the streetscape and to the extensive collection of well defined bungalow style residences in Gilroy.

The bungalow style is particularly suited to Gilroy. The overhanging rooflines, use of natural forms, cool materials, and sheltered windows are appropriate to the very warm climate in the South Santa Clara Valley. The importance of the bungalows in Gilroy is the representation of all styles, sized and materials. The total collection reflects the very best as well as more common interpretations, a text book of the bungalow movement.
