The double gable roofline in this California bungalow features wood slat decoration, exposed rafters at the eaves and large support beams. It has narrow clapboard siding except for the south wall which has been stuccoed. The veranda porch has elephantine pillars with cobblestone bases. The building is single storied and is designed on a rectangular plan. It is extremely well detailed and exhibits the distinctive vertical louvered gable screen which can be found in almost a dozen other residence throughout the city.
