Recommendation

It is recommended that the SCRWA Board select, by motion, a Chairperson, Vice Chairperson and Secretary for the fiscal year 2022-2023.

Summary

According to the SCRWA (Authority) bylaws, the Authority shall have three officers: Chairperson, Vice Chairperson and Secretary from among its Directors; the Chairperson and Vice Chairperson need to be a Director, but the Secretary may, but not need, be a Director. The officers hold office for a period of one year, commencing July 1 of each and every fiscal year. In the event that an officer is resigned, the SCRWA Board shall appoint another person to fill the vacant office for the remainder of that fiscal year. An officer may resign at any time.

According to the bylaws, in the absence or disability of the Chairperson, the Vice Chairperson shall perform all the duties of the Chairperson, and when so acting shall have all the powers of, and be subject to all the restrictions upon, the Chairperson. The Vice Chairperson shall have such other powers and perform such other duties as from time to time may be prescribed for the Vice Chairperson by the Board or by the bylaws. Additionally, vacancy caused by resignation of any officer may be filled by appointment by the Board, or by the Chairperson until such appointment by the Board.

The Secretary keeps at the principal office of the Authority a book of minutes of all meetings of the Board, with the time and place of holding, how called or authorized, the notice thereof given, and the names of those present at such meetings. The Secretary also attests to the signature of the Chairperson on all documents executed by the Chairperson on behalf of the Authority.

SUBJECT: Approval to Amend SCRWA Bylaws Section 3.01 - Changing the Date of the Regular Meetings of the Board

Recommendation

Staff recommends that the Board adopt a resolution establishing a new quarterly schedule for its regular board meetings.

Discussion

The Joint Powers Authority (JPA) agreement establishing the South County Regional Wastewater Authority (SCRWA) states that the Board of Directors (Board) shall meet once a year. According to the SCRWA by-laws, the meeting schedule can be adjusted by a subsequent by-law amendment.

When the JPA was initially established, there were two meetings per month due to significant legal and operational issues existing at that time. In 2009, by resolution of the Board, the by-laws were amended so that a single monthly meeting was conducted on the first Tuesday of each month at 7:30 AM. In 2012, a subsequent resolution changed the meetings to the first Wednesday of each month at 8 AM.

Since 2012, the Board has continued to meet on the first Wednesday of the month at 8:00 AM.

As the facility has implemented extensive capital improvements in the last 15 years and the long-awaited treatment capacity expansion project is under construction, there has been a significant reduction in the number of items for the Board to consider at each monthly meeting.

Due to lack of business items and in consideration of board/staff members time dedicated to the meetings, it is recommended that the Board amend the by-laws to incorporate a quarterly meeting schedule. Should it be necessary, special meetings can be scheduled if business items require more immediate attention, however this is not expected.

A draft resolution has been prepared for the Board's consideration.

Fiscal Impact

There is no fiscal impact associated with this item.



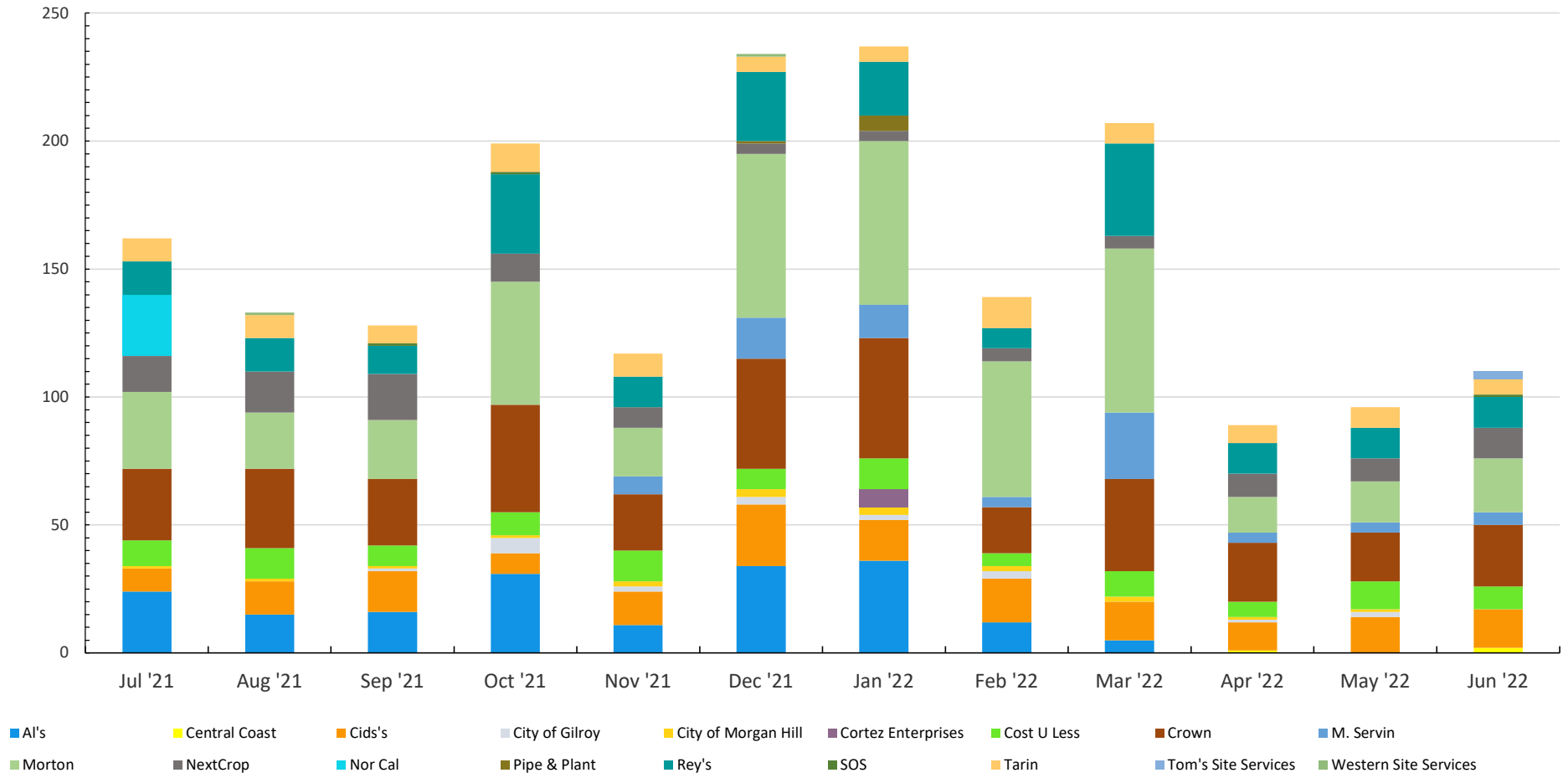
