**Type of Crime: ANNOYING A CHILD / ATTEMPTED KIDNAPPING OF CHILD**      **DATE: 8/4/11**

**Location:** Gilroy, California

**Details:**

**Incident #1**

On 7-26-11 at approximately 1735 hours, in the 7600 block of Miller Avenue, an adult male attempted to lure a ten year old female into his vehicle by verbally ordering her to walk over to him. The suspect pulled up in front of the residence while the victim was retrieving items out of her parent's vehicle that was parked in the driveway. The suspect was seated in his vehicle and ordered the victim into his car but she did not comply. The victim ran into the residence and told other family members about this incident and GPD was notified.

The suspect and vehicle were described as the following:

Hispanic male adult with short balding hair or a possible crew cut, a goatee, approximately 30 plus years old and wearing a white tank top with tan shorts. **A sketch is attached.**

The vehicle was described as a white 1990ish Honda 2-door with only the roof painted black. The vehicle was described as stock, no tint, after market wheels or modified exhaust. The vehicle was also described as "dirty".

**Incident #2**

On 08-03-11 at approximately 1449 hours, in the 900 block of Ortega Circle, an adult male attempted to lure an 11 year male, 15 year old female and a 9 year old female to leave the area and accompany him to a local eating establishment. The children declined the suspect's request and immediately notified a parent. The suspect was last seen walking away from the area and it is unknown if he was associated to a vehicle.

The suspect is described as:

Hispanic male, 20 – 25 years old, 5'8" to 5'9" tall, approximately 160 pounds, with a shaved dark brown hair, a mustache, and brown eyes. The suspect was wearing a gray t-shirt and khaki jeans.

Gilroy Police Detectives are actively investigating both incidents. Preliminary information **does not** suggest that the incidents are related or the same suspect is responsible for both incidents.

The Gilroy Police Department would like to take this opportunity to remind parents to speak with their children regarding their child's safety. 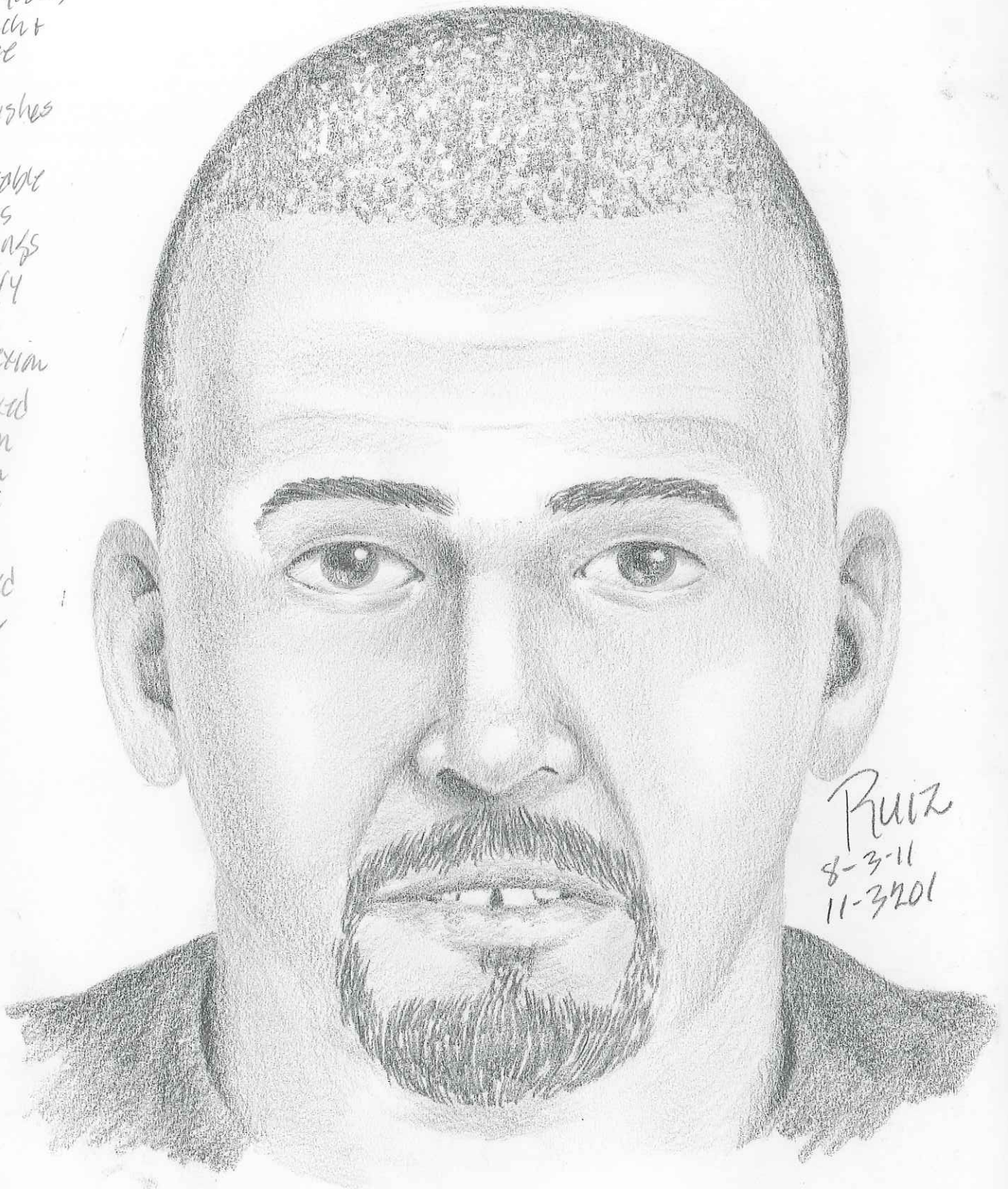
