## Details

On 01/11/11 at 23:10 hours GPD units responded to a disturbance call at a residence in the 7200 block of Church St. When the officer arrived at the scene they found a 32 year old male in the residence suffering from several blunt force injuries to his head and body. Officers also found three adult females and two children residents inside who were not injured. The suspects had fled the scene on foot.

During the preliminary investigation officers determined that three suspects committed an attempted home invasion robbery forcing their way into the house after confronting the victim who answered the front door. The suspects were armed with a firearm, hammer and crowbar. The suspects attacked the victim inside his residence in front of the other occupants of the house while the victim tried to defend himself. During the incident at least one of the suspects demanded money from the victim. The victim was able to defend himself by disarming one of the suspects and striking him with the hammer on the head. All three suspects then fled towards the front of the residence onto Church St. Nothing was taken during the incident. The victim was taken to a bay area hospital with non-life threatening injuries.

The suspects are described as follows:

#1 HMA 30y/o 6'0" tall 190 lbs wearing a white colored "Halloween" type mask, blk. hooded sweatshirt, gray sweatpants armed with a sawed off rifle or shot gun.

#2 HMA 30y/o 5'6" tall 160 lbs wearing a gray hooded sweatshirt, gray sweatpants, armed with a hammer.

#3 HMA 30y/o 5'10" tall 190 lbs wearing a blk. hooded sweatshirt, gray sweatpants, armed with a crow bar.
