Dear Parent or Guardian,

Thank you for your interest in having your child participate in the Gilroy Youth Center.. Given the unique circumstances due to the current COVID-19 pandemic and Santa Clara County Public Health Mandatory Directives for Programs Serving Children or Youth, the Gilroy Youth Center has implemented several changes to our program to prioritize the health and safety of your child, family, and staff. We will make modifications accordingly based on health directives. In accordance with Santa Clara County Public Health's Directives, these current guidance include:

- **Confirmation** – We will contact you once your application has been approved and confirm what session your child has registered for.

- **Waitlist** – If all spaces are filled for a session, your child will be placed on a waitlist. If a space becomes available as the session starts, you will be notified.
- **Late Enrollment** – Students may enroll in any session that has already started once their application has been approved.
