This house sits on concrete sill. Fish-scale shingles cover the front gable, while classical pillars replaced by wrought iron and railings flank the entryway steps. Fake rock has been erected on the exterior walls of the recessed front porch and the back porch has been completely enclosed with siding. The east side window has been redone.
