A single story structure of "T" form has a cross gable plan. The projecting front gable has an inset second projecting gable for the entry porch. The front porch extends across the width of the projecting gable and is supported by turned posts with brackets. The front porch railings are straight stick. Windows on the side wings are with crown and lungsil in classical molds. The structure is sheathed in wide horizontal board.
