This one story structure is a crossgable form with a small porch covered by a hipped roof. The modest structure has one window in the gable end and one window next to the door. Paired windows are on the side of this small cottage. The windows have vertical board shutters with cutout designs. The gables are recessed and the eaves boxed. Horizontal siding covers the structure and is finished with vertical corner boards.
